- The four courses noted above were developed completely new.
- The program was approved and added for the fall of 2013 for the 2013-2014 school year.

- The program is the only undergraduate program in Franchising Management offered as a full major in the United States. (There are programs offering concentrations or graduate certificate programing).
- As Department Chair and Program Quality Leader, I lead the Franchising Management Department, which averages around 3-5 full-time undergraduate students. (First through fourth year).
- The Franchising Management Program is being phased out at Northwood University.
